

#### A Note on Professional Development

The current SR/WA Review Study Session and Exam is intended for SR/WA candidates under the old program. The review study session and the capstone exam given at the end of the review class is not intended for individuals under the new program.

The new Industry Pathway Certification Program has four different capstone
exams — one for each industry pathway. But unlike the old Generalist
Program, the new program currently has no review class for the capstone
exam. However, for individuals under the new program, the current SR/WA
Review Study Session is a good general review to add to their own focused study
of materials. But they should not take the SR/WA comprehensive exam at the
end of the class.

Under the new program, the capstone exam is taken after completing all the required coursework because the exam questions are based on the specific courses they completed as part of the Industry Pathway. Since the new program will test the material taken in their specific industry, it is highly suggested that they review the material from each of those courses in detail on their own.

### Overview: Region 5 Spring Forum

On April 28<sup>th</sup> -30<sup>th</sup>, your intrepid President, Matt Chapman, MAI, along with International Directors Leigh Karr, SR/WA and I, Wayne Kimbel, ventured to the 2017 IRWA Region 5 Spring Forum. This Forum was hosted by the IRWA Illinois Chapter 12 at the Crowne Plaza Conference Center located in Rosemont, Illinois near O'Hare Airport. The venue and facility quality for the Forum could not have been more ideal for this event. The Forum included the International President and Region 5's very own Mary Anne Marr, SR/WA as well as the Executive Vice President, Jeff Jones SR/WA, also hailing from Region 5. Kudos to Cassy Beary, Chapter 12 President, for her fine work in overseeing the planning for this Forum. Praise also to Kris Koehler, Region 5 INEC representative and immediate past Chapter 12 President, along with their other Board members for all the work to make it a success. The Forum came on the heels of a successful symposium sponsored by Chapter 12 on April 28th titled "International Electric and Utility Symposium". Several attendees I spoke with gave it very high marks.

The hospitality extended to other Region 5 chapters began with a gathering on the evening of April 28<sup>th</sup> where attendees connected and reconnected with those from other chapters. The core business session on April 29<sup>th</sup> included details on the proper manner in which all IRWA chapters and regions should be conducting elections as well as supporting documentation important for them. One valuable take-away was a handbook developed by IRWA for Chapter Presidents, both incoming and outgoing. It included the management and fiscal responsibilities that need to be shouldered by that office. The list is quite extensive, but a key core theme is "delegation". The submission of proper reports to International headquarters was stressed and a sample spreadsheet from an unidentified region showed a varying level of compliance. Chapters receive financial incentives for compliance so it pays to heed those terms and deadlines. Chapter 25 has been diligent in that regard and with new clarification on certain elements will improve going forward.

A draft of highlights for the Fiscal 2018 budget was reviewed that gave summary of assumptions. There were anticipated revenue increases in some categories; decreases in others. Classroom and online education is expected to rise and along with memberships. Declines are predicted in investments and conference income. Expense increase are primarily in education and costs of benefits. One highlight of the Forum for me and many others was a presentation on proper Parliamentary rules by Deborah A. Underwood, President of the Illinois Association of Parliamentarians. I didn't know such a profession existed, but her details of what organizations should be doing vs the typical processes was eye opening. Chapter 25 will be revisiting its Board meeting protocol to make sure it conforms better to the rules.

Brad Krabel SR/WA was awarded the Region 5 Professional of the Year. Brad did his usual fun auction of various items to raise a bit of funds for the IRWA RWIEF fund. Ron Barker SR/WA gave a summary of the state of the fund, which is strong with a large infusion occurring at the last conference in Nashville, TN. The Forum concluded with a review of the upcoming International conference in Anchorage, Alaska along with some discussion on the bidding process for the 2022 conference from Charlotte, NC, Denver, CO, and Cleveland, OH. The buzz at the Forum was touting Cleveland, of course.

I've included a sheet (below) that shows the Key Measures for IRWA income for past periods. These numbers tell the source of funds and membership data for the organization by category. Take a few minutes and look it over.



# Parklands of Floyds Fork

Survey • Permit Drawings • Final Design • Construction Inspection





In 2014, Qk4 received an Engineering Excellence Grand Conceptor Award from the American Council of Engineering Companies (ACEC) of Kentucky. The Grand Conceptor is the most prestige of the ACEC Engineering Excellence Awards.

One of the world's most ambitious urban parks projects, its 3,800 acres now provide a rich variety of experiences for visitors. Miles of paved trails traverse streams snake through thick forests and glide under an active train trestle. Busloads of schoolchildren explore a Disney-esque manmade wetland where they can see, listen, smell, and discover with their own hands. The Great Wall of Distillery Bend eases pedestrians, wheelchairs and bikes up a 33% grade via a meandering trail that preserved a treasured forest and archaeological site. The 41-foot wall is the tallest built of prefabricated stone reminiscent of Kentucky's limestone bedrock. The Parklands of Floyds Fork does what Olmsted's parks did for Louisville a hundred years ago—improves lives and attracts business by bringing nature to neighborhoods while rising to his legacy.

The Louisville legacy of Frederick Law Olmsted, designer of New York City's Central Park and Louisville's own 19th century parks, provided inspiration for The Parklands of Floyds Fork.

Qk4 served as lead engineer for the most recently designed sections of the Parklands of Floyd's Fork, which include the now constructed phase three, and phase four, currently under construction. Qk4 provided civil and structural engineering design, survey, and construction inspection services for the park's gorgeous network of trails, roadways and bridges, and fulfilled the KYTC prequalification requirements of the design team.

Within the constructed phase three area, Qk4 applied existing engineering techniques in innovative ways in two distinct sections of the project, the Humana Grand Allee Wetlands and The Great Wall of Distillery Bend. The Humana Grand Allee Wetlands was engineered for beauty, study and enjoyment. For this manmade wetland, engineers adapted techniques typically used to preserve natural wetlands. To create a natural water source sufficient for the size of the wetland, they expanded the primary water source by diverting water via pipes and ditches from one pond to another. Qk4 then designed a unique supplemental water system from municipal water to sustain the manmade wetland. This technique ensured that, in dry times, visitors could enjoy uninterrupted beauty rather than staring at a crater of cracking clay, wondering, "Are those the wetlands?" Instead, the wetlands remain wet, and in the eyes of one observer, "Disney-esque." For The Great Wall of Distillery Bend, Qk4 helped stretch the limits of the only building material that met the client's construction and aesthetic requirements. The 41-foot high retaining wall (15 feet taller than the Great Wall of China!) is the tallest yet created from this particular material that preserves the look of Kentucky's natural limestone. During detailed design, Qk4 was challenged to solve a 50-foot change in grade and a 33 percent natural slope, while preserving treasured trees, habitats and archaeological sites.
